Limited Warranty for Sunport Power PV Flexible Modules

江苏日托光伏科技股份有限公司对本公司光伏组件产品作出本质量保证。

Jiangsu Sunport Power Corp., Ltd. ("Supplier") shall guarantee the quality of PV Flexible modules of our company.

一、产品质量保证 Quality Warranty

1.1 江苏日托光伏科技股份有限公司将向买方提供经过相关机构(如 TUV)认证过的光伏组件产品(买方同意的有特殊要求的产品除外);同时,产品外观符合买方与江苏日托光伏科技股份有限公司约定的外观标准。

Supplier will provide the buyer with products certified by the relevant institutions such as TUV (except for the products specially required by the buyer); the appearance of the products must be consistent with the standards of appearance as agreed by the buyer and supplier.

1.2 江苏日托保证其所生产的光伏组件(包括直流连接头和电缆)在正常使用、安装条件下,不会出现材料和工艺原因导致的不符合IEC61215、IEC61730、UL1703标准中定义的严重外观缺陷及功率异常的外观缺陷。如最初客户发票所示之日起 12 年内出现材料和工艺不符合IEC61215、IEC61730、UL1703标准中规定的严重外观缺陷及功率异常的外观缺陷,江苏日托将根据具体情形,与客户协商决定选择修理、更换,或按组件损坏程度赔偿客户。上述三种补偿均为唯一补偿办法,不可与其他补偿方式同时享受,且不能超过本质保书规定的12年的期间。

Support warrants its Photovoltaic Solar Modules (including factory-assembled DC connectors and cables) to be free from serious visual defects in materials and workmanship which defined in IEC61215、IEC61730、UL1703 or cause abnormal power output under normal application and installation. If the mentioned visual defects appeared in a period twelve years from date of sale as shown in the invoice to the direct customer of Support, Support will determine in consultation with the customer either repair or replace the product, or refund the purchase price as paid by the customer. The repair or replacement or refund remedy, at the option of Support, shall be the sole and exclusive remedy provided under the "Limited Product Warranty" and shall not extend beyond the twelve years' period set forth herein.

二、线性功率保证 Linear Performance Warranty

2.1 交货组件功率的测量应在标准测试条件下进行,即光强 1000 W/m²,温度 25°C,大气质量 AM1.5。

The DC power of a product shall be tested under standard test conditions which are: light intensity 1000 W/m², temperature 25°C, and AM 1.5.

2.2 买方必须保证对产品合适的搬运、系统设计、安装、使用、环境及维护。

The buyer must ensure to properly handle, transport, design the system of, install, use, and keep appropriate environment and maintenance for the products.

2.3 组件功率

Power of Module:

a) 单晶硅组件: 自系统安装并正常运行第一年,输出功率不小于该产品说明书所述最低输出功率的 97.5%; 第二年,输出功率不小于该产品说明书所诉最低输出功率的 96.8%; 以后平均每年输出功率衰减不大于上一年该产品输出功率的 0.7%; 25 年后产品输出功率不小于其说明书所述最低输出功率的 82.36%。

Mono-crystalline Si module: within the first year from the date of installation and normal operation, the output power shall not be less than 97.5% of the product's minimum output power as set forth in the specifications. Within the second year, the output power shall not be less than 96.8% of the product's minimum output power as set forth in the specications. Afterwards, the loss of average annual output power shall not exceed 0.7% of the product's output power of the immediately preceding year. After 25 years, the product's output power shall not be less than 82.36% of its minimum output power as set forth in the specifications.

2.4 如果在条款规定的时间内,组件的输出功率未达到以上约定的输出功率,江苏日托光伏科技股份有限公司将与买方一同分析原因。如江苏日托光伏科技股份有限公司确认属于己方责任,江苏日托光伏科技股份有限公司将提供在商业合理范围内最好的补偿方案,如提供额外的组件,修复或者更换组件,依据本质量保证书提供补偿金,延续原始提供的组件的质保期限等。如果当时提供的产品已经停止生产,江苏日托光伏科技股份有限公司将提供正



在生产的标准产品作为补偿。

If the output power of the module does not meet the above levels within the time specified, the supplier and the buyer

will jointly analyze the causes. If supplier determines that the liability is attributable to itself, then supplier will provide the buyer with best remedial choices commercially reasonable, such as providing additional module, repairing or replacing the module, providing the buyer with compensation in accordance with this Limited Warranty, extending the warranty period for the original module, etc. If the supplier has ceased to manufacture the module in problem, the supplier will provide the standard products it is manufacturing as remedy.

2.5 组件功率不足的补偿: 对组件实际总功率与该批次组件承诺总功率的差额部分, 江苏日托光伏科技股份有限公司以提供相应功率组件的形式予以补偿。

Compensation for the shortage of power: For the difference between the actual total output power and the committed total output power, the supplier will compensate the buyer with additional modules having the equivalent power.

三、前提 Preconditions

3.1 由于雷电、暴风、冰雹、洪水、火灾、地震、战争、 动乱等自然灾害或人为因素造成的非产品本身质量原因导 致的损失不在质保范围内。

Losses caused by natural disasters, such as lightning, storm, hail, flood, fire, earthquake, war, and unrest, caused by the quality of non-product itself, are not within the scope of the warranty.

3.2 本质量保证书不包括退赔故障组件在路途上的运输费用,也不包括装卸货产生的费用或者由此产生的其他费用。

This Limited Warranty covers neither the transportation charges of the products to be returned, nor the unloading and reloading charges and other charges such occurred.

3.3 本质量保证书不包括任何产品型号或编号标识模 糊不清的情况。

This Limited Warranty does not cover the situation that the type and serial number of any products are illegible.

3.4 买方必须保证对产品合适的包装、搬运、存储、 系统设计、安装、使用、环境及维护。

The buyer must ensure proper package, handling, transportation, storage, system design, installation, use, environment and maintenance for the product.

四、质保转让 Warranty Transfer

4.1 本质保书适用于最终用户,最终用户是指组件的

最终使用者,同时要求组件为首次安装使用。

These warranty terms exclusively apply to END-CUSTOMERS. END-CUSTOMER in terms of this warranty is the purchaser of the respective PV-Module, who has purchased the respective PV-Module for end-use and has installed the same for the first time (First Installation).

4.2 本质保书对于已安装使用的组件,可以从最终客户转移给另外的用户,客户必须保留原始的安装信息,同时要求组件为首次安装使用。

This warranty is transferrable by an END-CUSTOMER to the purchaser of an already installed PV-Module insofar as the PV-Module remains at its original place of installation.

五、质保免责声明 Warranty Disclaimer

除上述明确列出的内容外,江苏日托光伏科技股份有限公司和买方对产品或其他事项均未做出任何口头或书面、明示或暗示的陈述、保证或担保。该等被排除的暗示性的保证包括但不限于: (1)关于适销性的保证; (2)适合于某一特别目的的保证: (3)不侵权的保证。
